KNOW ALL MEN BY THESE PRESENTS that the undersigned (hereinafter called "the Releasor), for an in consideration of the payment of the sum of _____ DOLLARS (\$ _____), receipt whereof is hereby acknowledged, DO HEREBY AGREE to release and forever discharge, and by these presents do for my heirs, executors, administrators, successors and assigns remise, release and forever discharge _____ (hereinafter called "the Releasee"), their heirs, executors, administrators, successors and assigns of and from any an all actions, causes of action, claims and demand, suits, debts, duties, sums of money whatsoever or wheresoever, where at law of in equity and whether known or unknown, suspected or unsuspected, which the Releasor or heirs, executors, administrators, successors and assigns has or hereafter can, shall or may have, and in particular, but without restricting the generality of the foregoing, with respect to, or which has resulted from _____

AND it is agreed that in consideration of the sum of money heretofore mentioned, the Releasor does hereby release and forever discharge the Releasee from any and all actions, claims and demands under the Insurance (Motor Vehicle) Act, R.S.B.C. 1979, c.204 and the Regulations to the Act (including Part 7 of the said Regulations).

AND the Releasor DOES HEREBY DECLARE that in making this release and agreement it is understood and agreed that the Releasor relies wholly on the Releasor's own judgment, belief and knowledge of the nature of this contract and has not been influenced to any extend whatsoever in making this Release by any representations or statements regarding the rights of the parties hereto made by the Releasee or any person or persons representing them.

IT IS FURTHER UNDERSTOOD AND AGREED that for the consideration expressed herein the Releasor agree not to make any claim or take any proceedings against any other person or corporation who might claim contribution or indemnity from the Releasee or any of their officers, employees, servants, agents, predecessors, successors or assigns.

IT IS FURTHER UNDERSTOOD AND AGREED that the Releasor does hereby represent and declare that the Releasor alone is entitled to receive the monies payable in the settlement herein and that the Releasor has not assigned the monies or right of action to any person firm or corporation who might claim against the Releasee and further, that there are no liens, charges or mortgages concerning the monies payable herein.

WHEREVER the singular or masculine is used throughout this Release the same shall be construed as meaning the plural or feminine or the body politic or corporate where the context or the parties hereto require.

The Releasor state that the Releasor has carefully read the foregoing Release and knows the contents thereof and signs the same as the Releasor's own free act.
